## **VACANCY CIRCULAR**

Subject: Filling up of Section Officer post in Debts Recovery Tribunal-III, Chennai on deputation basis.

The Debts Recovery Tribunal is a quasi judicial body set up under the provisions of the Recovery of Debts Due to Banks and Financial Institutions Act, 1993 by the Ministry of Finance, Department of Financial Services, Government of India. It is proposed to fill up the post of **Section Officer -1 Post** (General Central Service; Group 'B' Gazatted; Non Ministerial) in the Tribunal by transfer on deputation basis.

Pay Scale: Pay level 7 (₹ 44,900 – 1,02,800) PB 2 – ₹ 9,300 – 34,800 +GP ₹ 4600/- (Pre revised)

**Eligibility Condition:** 

Officers holding analogous post on regular basis in Central Government/State Government/ Courts/Tribunals who possess a degree from a recognized University or with 8 years regular service in Pay Band-2 of Rs.9300-34800/- with Grade Pay Rs.4200/- (Pre revised) or equivalent who possess a degree from a recognized University.

Desirable: Preference will be given to persons having experience in legal or judicial work.

The period of deputation shall be initially for a period of one year but extendable up to three years. The appointment of candidates selected for the posts on deputation basis will be governed by the terms and conditions mentioned in Ministry of Personnel & Training orders bearing OM No. DOPT O.M. No 6/8/2009-Estt (Pay-II) dated 17.06.2010 as amended from time to time.

Age Limit for the post is 56 years as on the last date for receipt of applications in this Tribunal.
